Thereafter the Chairman commenced the formal agenda of the Meeting and with the consent of the members present, the Notice convening the Meeting, the Report of Board of Directors and the Standalone Financial Statements for the financial year ended 31st March, 2019 were taken as read.

With the permission of Chairman, Mr. Sudipto Seal, CFO then read out the relevant parts from the Independent Auditor's Report on the audit of the Standalone and Financial Statements of the Company for the financial year ended 31st March, 2019.

The Chairman delivered his speech and made presentation on the operational and financial performance of the Company for the financial year ended 31st March, 2019.

The Chairman then informed the members that as per the applicable provisions of the Companies Act, 2013 and rules enacted thereunder read with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Secretarial Standard-2 issued by the Institute of the Company Secretaries of India on General Meetings ("SS-2"), the Company had provided remote e-Voting facility to the members to cast their vote electronically on all resolutions set forth in the Notice which opened on 24th September, 2019 at 9:00 am and closed on 26th September, 2019 at 5:00 p.m. Members who were present at the Meeting and had not casted their votes electronically were provided an opportunity to cast their votes by Ballot at the end of the discussion on all the business items at the Meeting.

Thereafter, the floor was open for discussion on the following items of business as set out in the Notice calling the Meeting and was put for members' approval:

Ordinary Business & Ordinary Resolutions -

1. To consider and adopt the audited financial statements of the Company for the financial year ended March 31, 2019 along with the reports of the Board of Directors and the Auditors thereon.





Special Business & Ordinary Resolutions -

- 2. Appointment of Mr. Raj Kumar Chhakara (DIN: 00465157) as Independent Director for the term of 5 years effective from June 19, 2019.
- 3. Re-appointment of Mr. Purushottam Khandelwal (DIN: 00319202) as an Independent Director for another term of 5 years.

Pursuant to the abovementioned items of business, we would like to inform that all the above Resolution(s) have been passed by the members of the Company with the requisite majority i.e. Resolution No. 1-3 as Ordinary Resolutions.

The Chairman along with the management team had clarified all the queries raised by the members.

The Board of Directors had appointed CA Alok Kumar Das, Chartered Accountants, (Membership No. 055737) as a Scrutinizer for conducting the voting by Ballot at the Meeting and remote e-voting process in fair and transparent manner and to report on the combined voting results of e-voting for the items as set out in the Notice of the Meeting.

Thereafter the Chairman thanked the members present at the Meeting and authorized CA Alok Kumar Das, Chartered Accountants and the Scrutinizer appointed, to take over the Ballot proceedings and submit his report thereon.

The Chairman informed the members that the voting results will be uploaded at the website of the Company and National Securities Depository Limited (NSDL), the authorized agency appointed by the Company for providing remote e-voting facility beside their submissions to BSE Limited (BSE) and Calcutta Stock Exchange Association Limited (CSE) where equity shares of the Company are listed.
